COVID Mitigations Addendum (Non-UC Operated)

The campus continues to manage the response to COVID-19, which includes several actions and mitigations that apply to visitors and non-affiliates (“Campus Visitors”) who come onto any University operated site and are defined in the Event and Visitor COVID Protocol

As a third party operating a program on UCSC facilities, the Organization warrants that it will implement the following for its program. For the avoidance of doubt, the Organization is solely responsible for implementing its own process to ensure that all of the following requirements are met by Organization’s employees, affiliates, volunteers, invitees, and participants.

COVID Vaccine Requirements:

- Third-party organizers, participants, and attendees, including minors, are required to
 - 1) show proof of full COVID-19 vaccination; or 2) have an approved medical exemption and submit to regular COVID-19 testing every four days.
 - 2) Please note: If a person requests a medical exemption the participant should show to the Organization documentation from their medical provider evidencing that they are not medically advised to be vaccinated for COVID-19.

Required COVID Mitigations:

- All Campus Visitors, staff, students, and faculty must follow the campus COVID-19 mitigation requirements that include:
- All camp and program participants, attendees, and organizers must comply with all public health requirements.
- All Campus Visitors regardless of vaccine status are required to complete a https://ucsantacruz.co1.qualtrics.com/jfe/form/SV_24vMSiDcxZp6VRX and show proof of securing clearance prior to entering UCSC facilities and physical spaces.
- Approved face coverings are required for everyone, regardless of vaccination status, and must cover the nose and mouth when indoors.
- Unvaccinated people must also wear an approved face covering over the nose and mouth outdoors when in crowded spaces.
- Campus Visitors may not come onto campus or go into any University facilities or physical spaces if they feel unwell or have recently tested positive for COVID-19 in the past 10 and may not come to campus until they have tested negative via a rapid antigen test.
- For indoor spaces, no drink or food is to be consumed in classes or seminars in order to eliminate the removal of masks during instruction. If food or beverages are served at other indoor meetings, meeting sponsors should follow any county specific guidelines related to food service. In addition, attendees should have the option to eat their meal outdoors if they desire.

Required COVID Testing:

- All participants and staff are required to show proof of a negative test taken within 48 hours of arrival or will need to take a rapid antigen test upon arrival.
- Unvaccinated participants must test every 4 days while on campus.

Required Actions in the Event of a COVID Positive Case:

- If an Organization employee, affiliate, volunteer, invitee or participant should test positive upon arrival to the University facility, they will need to leave campus and may not participate in any portion of Organization’s program that takes place on University facilities.

Compliance with this Protocol:

- It is the responsibility of the Organization to ensure compliance and verification of the above requirements for all of Organization employee, affiliate, volunteer, invitee or participant that are on campus during the term of this Conference Services contract.
